Please note these notices are being issued under the DIDOM act 2010 & as per rule 8 of the DIDOM rules 2011.

DSIIDC issued an order on 04.02.2021 & fixed these charges on a provisional basis @ 13.65 per sq. mtr. & accordingly served all these notices now.
